# **Privacy Policy**

This Privacy Policy is effective from 13<sup>th</sup> August 2023 as amended from time to time

This privacy policy ("Policy") relates to the manner LEO BARNES UNION OF SEAFARERS OF INDIA ("LUSI", "we", "us", "our") in which we use, handle and process the data that you provide us in connection with using the products or services we offer. By using this website or by availing goods or services offered by us, you agree to the terms and conditions of this Policy, and consent to our use, storage, disclosure, and transfer of your information or data in the manner described in this Policy.

We are committed to ensuring that your privacy is protected in accordance with applicable laws and regulations. We urge you to acquaint yourself with this Policy to familiarize yourself with the manner in which your data is being handled by us.

## What data is being collected

We may collect the following information from you:

- Name
- Date of Birth
- Occupational ID details
- Contact information including address and email address
- Demographic information or, preferences or interests
- Personal Data or Other information relevant/ required for providing the goods or services to you

The meaning of Personal Data will be as defined under relevant Indian laws

**Note**: Notwithstanding anything under this Policy as required under applicable Indian laws, we will not be storing any credit card, debit card or any other similar card data of yours. Please also note that all data or information collected from you will be strictly in accordance with applicable laws and guidelines. The content of your information shall be retained and used for future communication; conduct of grievance redress; offering welfare measures; support services etc., and shall be available for limited period as determined by LUSI

## What we do with the data we gather

## Your rights relating to your data
